They are looking at the same taxing district area as the Gooding Recreation District or the Gooding Fire District. The City of Gooding has agreed to rent the current library space to them. They would like to eventually build a new facility. There is a need in the community.

Shelly Bates, has had a request for message software for the courts. She has received a quote from Computers for O'messenger for a onetime fee for \$600.00 twenty users.
