Don Gill explained that they are in need of \$5,700.00 to promote Gooding County. The County does not have it in the budget this year and will consider it for next year

ELECTED OFFICIALS AND DEPARTMENT HEADS

Assessor Baldwin is starting up his assessment notices. He reported that the roof is leaking on the computer system and last year it leaked and ruined the floor. Karl Souza is going to patch the roof and get a bid for a seal coat on the whole roof. Don Gill, Fair Manager, reported he has received additional sponsorships for this year's events. They are going to have family night at the cost of \$40.00 for a family of five on Wednesday and Thursday nights. Jaime Lancaster explained that the Art Guild has been putting on the art classes on Fridays. The fair photography department are going to put on Photography workshop in May. Karl Souza, Building and Grounds, stated that he as painted the extension office and the carpet is going next weekend. New cameras are installed for PRIA. Treasurer Wines' office is taking application for a position in her department. Terry Ruby, Weeds Supervisor, is getting equipment ready and has a full crew. He is waiting to hear from the BLM or Union Pacific. They are need of insulation the room where they store chemicals. Carol Johnson, Juvenile Probation, reported that they need to shred some old documents. PERSI did not pass the House for Juvenile Probation rule of 80. Mental Health is an ongoing serious problem. Mario de Haro Marti, extension office, has posted one of their positions. The coordinator position should be posted in about two weeks. They cancelled the spring break activities due to the lack of interest. Cathy Harris, Planning and Zoning, reported building goes on and they received a CAFO application/expansion. Prosecutor Pember, reporter that an employee was involved in a five car accident while off duty. Sheriff Gough reported that the jail is full. ORDINANCE

Prosecutor Pember, explained that the IAC would like to have counties adopt an ordinance regarding oil and gas manufacturing. Commissioner Edwards stated that they adopted the ordinance in Payette County.

Commissioner Edwards moved to approve the minutes from March 12, 2018 and March 15, 2018. Commissioner Chandler seconded the motion. Motion carried.

MIDDLE SNAKE WATER REGIONAL RESOURCE COMMISSION
PUBLIC HEARING

Bob Muffley, Steve Hines and Lew Pence joined the meeting. Mr. Muffley explained the revisions of the Coordinated Water Resource Management Plan will correct grammar or other errors and update, eliminate or add new language to the water quality and economic portions of the Water Resource Management Plan. Larry Bybee, City of Gooding, was the only other in attendance. Steve Hines, Extension Educator from Jerome County, pointed some highlights in the Plan. The Plan is using 2012-2013 data. Agriculture drives the Magic Valley. Magic Valley has 67% of the States agriculture. That water is a precious commodity. Magic Valley has continued to grow due to the water quality. The productive of value of water is used to look at job creation. 3.6 direct and indirect agriculture related jobs are created for every 80 acres of irrigated farm ground. Public Hearing closed at 2:35 p.m.

GOODING COUNTY MEMORIAL HOSPITAL DISTRICT

Commissioner Bolduc explained that a public hearing was held about two weeks ago and the Commissioner decided to share the funds be split 25% to the Hospital and 75% to the County. Prosecutor Pember explained the County can designate where the funds go. Mr. Muffley doesn't think any of the funds should go into Twin Falls County and supports building an ambulance facility that will facilitate Gooding County. Commissioner Chandler does not want change the motion. They will look at it again after the May 15, 2018 elections where the question's is asked to dissolve the Gooding County Memorial Hospital District.

CITY OF GOODING

Larry Bybee, Vern France, from the City of Gooding and Walt Nelson, former City of Gooding Mayor joined the meeting. Larry Bybee explained that they are going with DEQ funding. They have some issues with Airport Zoning matters for radio towers. Mr. Pember explained the towers were up prior to the ordinance of 2011. The City has an automated weather reporting system that it interferes with. Commissioner Bolduc has a resource that they use at SIRCOMM that he will get it to the City.

Chairman Bolduc adjourned the meeting at 3:25.
