JOINT OFFICE WITH LINCOLN COUNTY

The Board joined the Lincoln County Commissioner via the telephone. Joe James explained the operations of the Public Defender’s office in Lincoln and Gooding Counties. Gooding County has 2.5 Public Defenders and Lincoln County has one Public Defender with the need for 1.5 in the near future. There is additional financial assistance for joint offices from the Public Defenses Commission. Camas County has been contacted to possibly join the joint Public Defense office with Gooding County and Lincoln County; however they have not yet responded. The discussion was tabled until they hear back from the Public Defense Commission and from Camas County. Commissioner Bolton moved to table discussion on the Joint Public Defense office with Lincoln County until the end of May or the first part of June. Commissioner Buhler seconded the motion. Motion carried.
