**TAX DEED HEARING**

**Gooding County Tax Deed Hearing –**

**COLLECTION OF DELINQUENCY ON REAL, PERSONAL AND OPERATING PROPERTY  
§ 63-1005 – PENDING ISSUE OF TAX DEED –**

*If real property on which there is a delinquency is not redeemed within three (3) years from the date of delinquency, the county tax collector of the county wherein such property is situated must make, in favor of said county, a tax deed for such property. However, the county shall not be entitled to a tax deed for such real property until all items in § 63-1005 have been fulfilled. Upon recording the following Affidavit of Compliances stating that I have complied with all conditions of the issuance of notice of pending issue of tax deed described in § 63-1005, and stating particularly the facts relied on as constituting such compliance. Such affidavits have been recorded in the office of the county recorder. Serving as evidence that all such notices have been given.*

**§ 63-1006 – HEARING AND ISSUANCE OF TAX DEED**

*When a record owner or owners or any party in interest upon whom a notice of pending issue of tax deed is served or who has actual knowledge of such notice or its contents fails, to appear or otherwise defend and answer at the time set for hearing in such notice and the county commissioners are satisfied that the county tax collector has fulfilled the requirements of section 63-1005, Idaho Code, the county commissioners shall, without further notice, immediately direct the county tax collector to issue and record a tax deed in favor of the county.*
