REGULAR SESSION, JULY 6, 2021

Commissioner Bolduc opened the meeting at 9:00 a.m. Commissioner Buhler, Commissioner Bolton and the Clerk, Denise Gill were present.

PLANNING AND ZONING ORDINANCE WORK SESSION

The Board, Prosecutor Misseldine and Cathy Harris, Planning and Zoning Administrator continued their work on the Planning and Zoning Ordinances.

Commissioner Bolton read emails from two individuals objecting to the allowance of AIRBNB type of properties in residential areas.

Commissioner Bolduc had contact from two homeowners with the same complaint. The group discussed the changes that may need to be made to accommodate and control these homes.

PLANNING AND ZONING FEMA – FLOOD ZONES

Cathy Harris, Planning and Zoning Administrator, Larry Bybee, City of Gooding and George Yerion, Gooding County Surveyor joined the meeting. Wendy Shaw, FEMA Engineer, explained the Big Wood River and Little Wood River watersheds areas in Gooding County. Ms. Shaw stated FEMA would help in setting up the public meetings to inform the citizens on the changes in the flood zones. After the adoption of a Conditional Letter of Map Revision, FEMA will create new maps. The Corps of Engineers will help with the expense for the new maps.

Commissioner Bolton moved to authorize Cathy Harris to start a Letter of Map Revision with FEMA. Commissioner Buhler seconded the motion. Motion carried.

Gooding Highway District Road Grader agreement was tabled.

EMS BUILDING

Commissioner Bolton moved to accept the bid from ACE Electrical and Controls, for the installation of three electrical cords in the EMS Building and authorized Commissioner Bolduc to sign the acceptance. Commissioner Buhler seconded the motion. Motion carried.

The land next to the Transfer Station that Gooding County acquired needs a permit to use as landfill; Southern Idaho Solid Waste District, Chief Executive Officer, Josh Bartlome, explained to Commissioner Buhler. Commissioner Bolduc asked if Mr. Bartlome could give them what he envisions for a five-year plan.
