**FINAL ORDER OF THE GOODING COUNTY
BOARD OF COMMISSIONERS**

Order to Dissolve the Gooding)
Memorial Hospital Taxing District)

WHEREAS, Gooding County Memorial Hospital District (the “**District**”) is a hospital district that was organized under Idaho law and was the owner of NCMC. The District has historically levied and collected taxes, which together with other revenue sources, allowed for the ongoing ownership and operation of the critical access hospital known as North Canyon Medical Center and other health-related activities and facilities in and around Gooding, Idaho (collectively the “**NCMC**”).

WHEREAS, under Idaho Code Sections §§39-1325A, 63-4105, 63-4106, the Gooding County Board of County Commissioners (“**Commissioners**”) have the authority to dispose of the assets of a district hospital if a majority of the voters approve the dissolution of the district;

WHEREAS, on May 15, 2018 eligible voters decided to dissolve the District.

WHEREAS, the Commissioners and NCMC have signed a sale and lease proposal, whereby the assets of the District have been disposed of in accordance with Idaho Code §63-4105.

WHEREAS, on or about June 1, 2018 NCMC and the Commissioners signed the agreement which wound up the district’s business and affairs.

NOW, THEREFORE, BE IT ORDERED by the Gooding County Board of County Commissioners as follows:

1. That the Gooding Memorial Hospital District is dissolved and terminated
2. Notice of this termination, as well as this ORDER, shall be sent to the social security administrator at the Idaho State Controller’s Office as stated in Idaho Code §39-1325C(3).
