INTERLINK VOLUNTEER CAREGIVERS

Jeanette Roe, Executive Director for Interlink Volunteer Caregivers, discussed their impact in 2022. Transports in Gooding County was 5.5% of their total last year. They have 20 clients that are residents in Gooding County and it is increasing. They have had no funding from the Office on Aging. They have been applying for grants. Blue Cross did not fund them. Ms. Roe is requesting additional funding for 2024.
